TITLE: APPOINTMENT OF EXTERNAL AUDITORS**EXECUTIVE SUMMARY:**

We are now approaching the point at which we need to re-tender for External Audit Services. Following the abolishment of the District Audit Service a nationally procured External Audit Service came into existence from 1st April 2016. There are options available on how we procure the next External Audit contract. These include:

- Self-procurement through tendering procedures
- Local procurement with other local government bodies on a geographical basis
- Service-led procurement with other police bodies
- Procurement via a nationally-led process through the LGA.

To self-procure this service would require resource and would not achieve the economies of scale that have been delivered as part of a larger purchasing body.

There has been no appetite to date for either geographically based or service led procurement.

Therefore, without commitment the Chief Finance Officer wrote to the LGA expressing an interest in their nationally led procurement process, by the deadline the LGA set.

Since then the LGA has approached PACCTS to assist in obtaining the Police service as a whole expression of interest. With the exception of a couple of Policing bodies, this expression has now been made.

There may be a requirement to extend the existing contract to 2019/20, depending on how this procurement project develops. This is permissible within the existing contract.
