**TITLE: AWARD OF A SINGLE SUPPLY OF HARDWARE FOR NOTTINGHAMSHIRE  
POLICE'S AGILE WORKING STRATEGY**
**EXECUTIVE SUMMARY:****1. PURPOSE OF THE REPORT**

The purpose of this report is to recommend approval for award for "A single supply of hardware for Nottinghamshire Police's agile working strategy" to Computacenter UK Ltd.

**2. SUPPORTING INFORMATION**

East Midlands Strategic Commercial Unit (EMSCU) undertook a single procurement activity for Nottinghamshire Police and included Northamptonshire Police in respect of their requirements for resources to facilitate the implementation of an agile working strategy with IT equipment being standardised across both forces. The IT equipment sought through this new tender comprises of monitors, laptops, laptop charging docks, keyboard, mice and laptop carry cases.

This procurement was undertaken against Lot 1 'Hardware' of the Crown Commercial Service (CCS) framework RM3733 'Technology Products 2', which was deemed to be most appropriate for this tender. A mini competition was carried out inviting all of the suppliers on this Lot to bid.

The suppliers were given one working week to bid. Of the thirty suppliers invited eighteen expressed interest and four submitted a response.

The outcome of this single procurement activity is two contracts – one for each of the forces named above.
