TITLE: AWARD OF CONTRACT FOR ONE POINT DISPOSAL (NON-POLICE VEHICLE DISPOSAL)

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for award of a contract for one point disposal services to Rawk2k.

2. SUPPORTING INFORMATION

Due to long standing issues with the HMRC concerning the VAT element in the disposal of unclaimed vehicles seized by police forces the NPCC Vehicle Recovery best guidelines recommend a one point disposal scheme to provide a full 'cradle to grave' audit trail for VAT purposes.

Leicestershire Police conducted a Framework on behalf of the East Midlands forces.

Therefore this report is to recommend approval to award a call off contract to the successful supplier.

End of life vehicle are to be disposed of through licensed Authorised Treatment Facilities (ATF) in accordance with End of Life Vehicle (ELV) Regulations, as per European Regulations Directive 2000/53/EC dated 18th September 2000 (End of Life Regulations).

Scrap Metal Dealers Act 2013 and Scrap Metal Dealers Act 2013 (Commencement and Transitional Provisions) Order 2013 (SI 2013/ 1966) – it is a requirement of the framework that every Motor Salvage Operator (as defined in the Act) being used for the scrapping or dismantling of vehicles will be registered and licensed by the local authority within whose areas they have their site.

The Force dispose of vehicles as per the table below, vehicles suitable for sale by auction have a reserve set at £350, the remainder are for dismantling and recycling with a requirement for a DVLA Certificate of Destruction

The requirements will cover the following vehicles (regardless of whether they are classified as end of life vehicles or not) and property (including but not limited to):

- commercial vehicles, including trailers
- cars
- motorcycles (of all descriptions)
- mopeds
- boats
- caravans and motor homes
- plant
- trailers of all sizes
- vehicle components

This contract will be for the disposal of vehicles, vehicles will either be sold for their scrap value or sold at auction. The income from sale of the vehicles is intended to cover the duty garage recovery and storage costs, with any surplus funds once these expenses have been met being retained by the Force. The surplus funds are not likely to be of any significant value due to the standard of vehicles being disposed of. The majority of funds made from the vehicles will go to the duty garages to cover the costs of storage and recovery. This contract will be broadly a cost neutral contract.

The tender was advertised on both OJEU and Contracts finder through links from EU-Supply. The EMR Terms and Conditions for the supply of Services (HIGH) were used for this framework.

Ten responses were received, but only five of the responses were compliant:

The value of this Contract depends upon the number of vehicles disposed, based on Nottinghamshire' figures for 2015/16 and applying the RAW2K costs it is estimated that the vehicle recovery garages gross income will be £311,250 pa.

Over the four year initial contract period the total income split across the vehicle recovery garages will be £1,245,000. Over the full six years the figure is, income for duty garages £1,867,500. This income will be offset by expenditure incurred by the garages.
