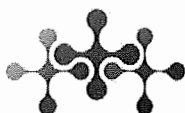

**TITLE: AWARD OF TELEPHONY TRANSFORMATION SERVICES (TRI FORCE)****EXECUTIVE SUMMARY:****1. PURPOSE OF THE REPORT**

The purpose of this report is to recommend approval for the award of contract for the provision of professional and technical services to recommend a Cisco Unified Communications Manager (CUCM) single telephony platform for Leicestershire, Northamptonshire and Nottinghamshire Police (the Tri-Forces), for a period of 3 years by Datrix Limited for the total contract value of £535,251.56.

**2. SUPPORTING INFORMATION**

This is a new provision for the development of a single telephony platform for the Tri-Forces. The new platform will involve bringing each individual Force system up to the level of the currently most mature CUCM used by an individual Force. A separate contract has been secured to provide Licenses across the whole platform. This Contract secures a Cisco solution provider who can provide integrated professional and technical services to recommend an end to end solution including design, hardware, software/ licensing, migration methods and an implementation plan, the hardware and software build of the infrastructure for the single telephony platform and ongoing support and maintenance.

It is expected that the total cost identified above £535,251.56, will be met from the Tri-Force Transformation Funded Project, however this contract will result in on-going charges to each of the three forces from 2020/21, which will be recharged by Nottinghamshire Police in accordance with the number of licenses purchased. Nottinghamshire have built this charge into the MTFP. It is also anticipated that there will be some savings to mitigate this on-going cost from existing telephony maintenance and support contracts, however until the project is further forward these savings cannot be quantified.
