TITLE: NOTTINGHAMSHIRE POLICE AND CRIME SURVEY 2017/2018

EXECUTIVE SUMMARY:

The PCC plans to commission a robust and representative general population survey for the police force area which will seek to monitor and enhance our understanding of:

- Prevalence and frequency crime experienced by Nottinghamshire residents.
- Levels of crime reported to the police and reasons for not reporting.
- The needs of victims of crime and extent to which those needs are met.
- Awareness of pressures on and changing focus of policing services.
- Customer insight, including preferred reporting and engagement methods.
- Public views on policing priorities and the precept for policing.
- Levels of trust and confidence in local police.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

Nottinghamshire OPCC regularly consults and engages with local residents, partner agencies and other stakeholders via a range of methods as part of an annual cycle of planning and priority setting. Consultation methods include questions contained within the Nottingham City and Nottinghamshire annual resident surveys, OPCC-led face-to-face engagement and online questionnaires and independently facilitated focus groups commissioned by the OPCC.

While this diverse range of consultation methods collectively presents a rich picture of resident perceptions, experience and attitudes, it does not currently provide a consistent, robust and comparable picture across the wider police force area. The PCC aims to introduce a single robust and representative Police and Crime Survey for Nottinghamshire in view of the following strategic drivers:-

- Development of the PCCs new Police and Crime Plan and performance framework for 2018-21, coinciding with the Commissioner's second term in office and the newly established Chief Officer Team.
- Introduction of new police continuous improvement programme / priority plan between April and September 2017 which aims to further develop workforce capacity, learning and development and organisational leadership.
- The need to further develop our understanding of communities as identified via the 2016 round of HMIC PEEL inspections.
- Statutory duties to engage with local communities on local policing matters, consult with local people in identifying and setting local priorities and consult the public and local rate

payers prior to issuing the policing precept.

Commissioner's and Chief Constable's shared ambition to "give victims and citizens a bigger voice in policing" and to "engage our communities to ensure we understand their needs".

The proposed survey programme will introduce a unique set of local crime and policing-specific indicators to inform policy and practice – and will avoid duplication with existing Local Authoritylevel consultation processes.
