### TITLE: AWARD OF TELEPHONY TRANSFORMATION SERVICES EXTENSION (TRI FORCE)

#### EXECUTIVE SUMMARY:

##### 1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the extension of the award of contract for the provision of professional and technical services to recommend a Cisco Unified Communications Manager (CUCM) single telephony platform for Leicestershire, Northamptonshire and Nottinghamshire Police (the Tri-Forces). Additional work and equipment has been identified that requires additional expenditure totalling £130,270.10, (£70,270.10 for hardware plus £60,000 technical support).

##### 2. SUPPORTING INFORMATION

A detailed designed session took place which identified that the current version of equipment in place would come to the end of life partway through the project timescales; therefore it has become necessary to upgrade the current equipment. The total cost of equipment and support is £70,270.10. Provision has also been made for technical support from Datix to assist with installation; however this will only be called upon if required.

The total cost identified above £130,270.10, will be met from the Tri-Force Transformation Funded Project, however this extension may result in on-going charges to each of the three forces from 2020/21, which will be recharged by Nottinghamshire Police in accordance with the number of licenses purchased. Nottinghamshire will build this charge into the MTFP once identified. It is also anticipated that there will be some savings to mitigate this on-going cost from existing telephony maintenance and support contracts, however until the project is further forward these savings cannot be quantified
