**TITLE: AWARD OF WAN SERVICES CONTRACT (TRI FORCE)**

**EXECUTIVE SUMMARY:**

**1. PURPOSE OF THE REPORT**

The purpose of this report is to recommend approval for the award of contract for the provision of professional and technical services to assess the current networks and provide recommendations on how to best progress a single WAN solution, making use of a Cloud service to provide services to circa 170 sites for Leicestershire, Northamptonshire and Nottinghamshire Police (the Tri-Forces), for a period of 1 year by Datrix Limited for the total contract value of £26,650.
