# TITLE: AWARD OF WAN SERVICES EXTENSION (TRI FORCE)

#### **EXECUTIVE SUMMARY:**

#### 1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the extension of a contract for the provision of professional and technical services to assess the current networks and provide recommendations on how to best progress a single WAN solution, making use of a Cloud service to provide services to circa 170 sites for Leicestershire, Northamptonshire and Nottinghamshire Police (the Tri-Forces), for a period of 1 year by Datrix Limited for the total contract value of £129,100.

#### 2. SUPPORTING INFORMATION

Datrix were awarded the contract to recommend the technical solution including kit specification, configuration templates, and hardware recommendation to future proof the solution and recommend an Implementation Plan. Within their tender they were asked to offer Project Management and on-site deployment services as an optional extra. It is intended to now commission that work on a call-off basis when necessary to meet the timescales of the project. Not all the optional deployment services may therefore be required.
