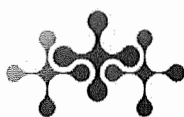

TITLE: AWARD OF IDENTITY AND ACCESS MANAGEMENT AND PUBLIC KEY INFRASTRUCTURE (IdAM&PKI) (TRI FORCE)

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the award of contract for IdAM & PKI High Level design (HLD) to Mastek for the contract value of £331,000.

2. SUPPORTING INFORMATION

This is a new provision for the development of a HLD for single IdAM & PKI solution to be implemented by the Spring of 2018 and accordingly are looking for a HLD plan to be in place by the end of October 2017.

The aim is to deliver an infrastructure to allow any user in the region to log on to any workstation, laptop or mobile device and access any resource in the region to support the requirements of their role.

The development of a single IdAM & PKI solution is critical for other Tri-Force IT work streams, as other systems such as the single e-mail platform require authentication to function. Once the HLD has been detailed there will be a separate procurement for the implementation of the Design.

INFORMATION IN SUPPORT OF DECISION: (e.g. report or business case)

Recently the Tri-Forces have determined that in order to collaborate more closely they wished to rethink the approach to I.T. delivery; to focus on a strategy of consolidation across a number of key technologies, thereby providing a longer term benefits to the Tri-Forces and the wider East Midlands region.

The East Midlands Strategic Commercial Unit (EMSCU) is procuring this resource against the Crown Commercial Services (CCS) GCloud9 Digital Marketplace.


Tenderers had to be able to demonstrate that they are vendor agnostic and have no significant financial links with any IdAM & PKI system provider. The quality evaluation was based on the tenderers technical expertise; experience of IdAM & PKI design and implementation and the proposals for project management of the production of the High Level Design and ongoing engagement with implementation. The pricing evaluation was based on the submitted cost to produce the HLD and the continuing Expert Adviser/Critical Friend role.
