## TITLE: AWARD OF FRAMEWORK AGREEMENT FOR TELEPHONE INTERPRETING

## **EXECUTIVE SUMMARY:**

### 1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for award of contract to the bigword Group Limited for the provision of Telephone Interpreting for the period 01 August 2017 to 30 June 2019 with the option to extend to 30 June 2020, utilising CCS Framework RM1092 "Language Services" Lot 3 "Telephone Interpreting and Video Language Services."

## 2. SUPPORTING INFORMATION

The current contract for Telephone Interpreting is with Language Line, which is due to expire on 08.10.2017. This contract can be terminated prior to this date if we wish either formally or by ceasing to use the service.

Leicestershire performed a regional retender activity for the procurement of all Language Services for East Midlands Forces. The recommendation is that we move from Language Line to thebigword, using CCS Framework RM1092 Lot 3 (Telephone Interpreting and Video Language Services) which is one of the CLEP recommended routes to market; thebigword are the only supplier listed on this Lot.

A visit was arranged for the East Midlands and some West Midlands Forces to the bigword's head office in Leeds to establish how they operate. Their call handlers and translation services are based at their head office, with the majority (95%+) of their interpreters are home based in the UK. They work with the MoJ, the NHS and 10-11 other Police Forces; they handle 750,000 calls a year of which 70% are automatically connected to an interpreter using access codes and language codes when dialling in. A demonstration of how the system worked was provided; a Polish interpreter was reached in 13 seconds using the automatic system, and a Twi interpreter (very rare) via the operator in just over 2 minutes. Calls can also be prebooked and set up for a later date and time.
