### **TITLE: AWARD OF CONTRACT EXTENSION FOR AIRWAVE**

#### **EXECUTIVE SUMMARY:**

##### **1. PURPOSE OF THE REPORT**

The purpose of this report is to seek formal approval for Nottinghamshire Police to extend its current contract in place for the Emergency Services Network (ESN) with Motorola Solutions UK Managed Services as detailed below in the background information, at a cost of £416,726.24 per annum excluding VAT.

##### **2. SUPPORTING INFORMATION**

The various services of the current force Airwave contracts are due to end between 2017 and 2019 for all UK police forces. The ESN Programme has asked that all forces sign up to extending their current Airwave provision for a further period until ESN is delivered, reference communication from the NPCC dated 6 September 2016. This will result in extended coverage of related services until all services have moved over to ESN, as yet this date is unknown, contracts will be reviewed on an on-going basis and updates will be provided once dates are available.

No formal tender process has been conducted; this merely represents a request for approval of extension of the current contract.

With reference to the comments in Section 2 of this report it has been necessary to agree a Change Control Note (CCN) with the current service provider to extend the range of the various services currently provided for a further period of time. This period end date has been agreed by the National and Regional CSN Program to allow for continued business continuity in the absence of any actual firm dates in respect of ESN implementation currently being known.

Detailed discussions have taken place internally involving EMSCU Procurement, Finance and Nottinghamshire IS Departments in order to ensure:

- there is sufficient budget to cover this on-going requirement
- that any CCN raised contains the relevant future services that the force still requires and is for the correct length of time based on currently known dates based upon ESN and national shutdown and regional transition
- that the pricing reflected within the CCN reflects the best possible charges possible

The pricing does not contain the bundle choice for the Force, as this is reviewed annually by each individual force. Each Force notifies Airwave of their choice of Bundle by the end of February (each year), and the appropriate pricing then commences from 1st April, and remains the same for the financial year to 31st March the following year. As the Bundle choice may change, it was thought it best not to include in this package.
