TITLE: Signals from Noise Licences and Migration of hosting from Northants Police to Nottinghamshire Police

EXECUTIVE SUMMARY:

For the supply of Signals from Noise Licences and Migration of hosting from Northants Police to Nottinghamshire Police to be provided by Lightfoot Solutions UK Ltd for the period of contract 1st October 2018 to 30th September 2021.

This is a new contract with Lightfoot Solutions UK Ltd, following a successful proof of concept using a Northamptonshire hosted solution.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)


Nottinghamshire Police have successfully and extensively used the Signals from Noise system during a proof of concept period. It is widely used in force by the performance analyst function and increasingly by operational colleagues following the introduction of the 'dash-boarding' tool in 2017. The use of Signals from Noise has been identified as significantly increasing productivity in the analytical functions due to its ease of use to carry out analysis and drill down in to data.

Other similar business intelligence products from alternative suppliers have been considered during the period of the POC; however none of these alternative products have been able to evidence equivalent functionality to signals from noise.

The force now wishes to migrate the hosting from Northants to host the system themselves. They also want to purchase licenses, maintenance and support for a further 3 years.
