The purpose of this report is to inform and recommend approval for the award of a contract for the Provision of Criminal Justice Healthcare Services in Nottinghamshire.


The Provision of Criminal Justice Healthcare Services to be provided by Care & Custody Health Limited for the period of contract 1st May 2018 for three years.

A detailed procurement process supported the decision to award this contract to Care & Custody Healthcare Limited.

There is a saving of £6,287.34 per annum.
