**TITLE: AWARD OF ARCHIVE STORAGE REPLACEMENT FOR HI TECH CRIME UNIT AND TECHNICAL SURVEILLANCE UNIT AND POLIT MOVE.**

**EXECUTIVE SUMMARY:**

**1. PURPOSE OF THE REPORT**

The purpose of this report is to recommend approval for the contract Archive Storage Replacement for Hi Tech Crime Unit and Technical Surveillance Unit and POLIT move. This procurement will be purchasing a replacement/refresh of the existing archive storage we use for our Hi Tech Crime Unit (DIU) and Technical Surveillance Unit (TSU). The solution will also be used to accommodate the data being brought over on the POLIT move.

This will provide storage to meet the requirements for the next 5 years. With the appropriate warranty and maintenance for the same period.

The total contract value is £408,274.56.

**2. SUPPORTING INFORMATION**

The requirements we have mean it is a fairly niche selection of products which could deliver the storage capability we require. This will also cover some level of installation support for the first of the two sites. In addition, the price/TB has to be low as we need significant volume (700TB of usable storage at each of the two sites).

As well as the upfront costs for the initial procurement, CDW have committed to an expansion chunk cost (216TiB/237TB) £44,422.64 going forwards.
