TITLE: Extension of the contract for ECINS 12 months.**EXECUTIVE SUMMARY:**

The ECINS system has been funded by the OPCC for four years (2018/19 will be year five). During this period the system has become the Nottinghamshire wide system for multi-agency case management and data sharing.

There are no other open market solutions available off the peg and no bespoke system could be procured within a comparable price range.

There are approximately 1000 users across Nottinghamshire from 27 agencies using the system to support a range of business areas including (but not limited to) IOM, MARAC, VPP and Tasking.

The system contains in excess of 1700 profiles connected to approximately 1650 cases.

An extension of the existing contact without going to tender is required to ensure business continuity into year five of delivery with a view to using this period to examine and re-negotiate around the existing contract.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A favourable external review of the ECINS programme released in December has spurred the programme on to focus on a number of recommendations around the suggested strategic direction for 2018/19.

Last year was dedicated to establishing executive level and then subsequent organisational buy-in alongside the development of fundamental project management structures such as operations meetings, year two marks a period of focus on operational usage and harmonisation of policies and procedures alongside establishing effective governance and assurance strategies and polices.

The forward plan for the project is for managed transition of existing business practises alongside of the retrospective compliance and auditing of pre-existing business practises and long term user organisations or business areas.

It has been remarked by a local partner that it is now an 'odddity' if an agency is not on or at least aware of ECINS in partnership meetings which is a significant step forward in terms of the embedding and normalisation of the system.

ECINS is either in use for or transitional work is going on to transfer work to ECINS for:-

- ASB, encompassing all behaviours described in the Anti-social Behaviour, crime & policing act 2014:-
 - conduct that has caused, or is likely to cause, harassment, alarm or distress to any person,
 - conduct capable of causing nuisance or annoyance to a person in relation to that person's occupation of residential premises, or
 - conduct capable of causing housing-related nuisance or annoyance to any person
- Vulnerable persons - In the wider context of a number of business areas encompassing but not limited to rough sleeping, begging, modern slavery, missing persons, complex persons and victims or potential victims of crime.
- Management of offenders and offending behaviour – in particular IOM also encompassing the management of offenders in, out and through the prison system in the context of cohesive management with partners to reduce the risk of reoffending and to provide a raised level of care in terms of resettlement and effective provision against identified need.
