**TITLE: VARIATION OF WAN NETWORK CONNECTIVITY SERVICES CONTRACT**

**EXECUTIVE SUMMARY:**

**1. PURPOSE OF THE REPORT**

To recommend approval for the variation of contract for WAN Network Connectivity Services. This variation is to the contract already signed off for the purchase of the required WAN network connectivity to a centralised network data centre and any-to-any connectivity between all sites.

This variation is for 13 of the Nottinghamshire sites which are moving over on a contract amend in order for Virgin Media Business to allow us to remain on existing revenue prices (this saves us £15,747.60) annually. This is a direct award to Virgin Media Business for a period of 36 months, with a total variation to contract of £59,338.50 ongoing revenue cost.

**2. SUPPORTING INFORMATION**

This is a new provision to upgrade the network connectivity in support of the WAN equipment roll-out (TRI1000012) for Nottinghamshire Police. As part of an earlier consultation the required hardware has been specified and verified by Nottinghamshire and is currently being rolled out.

This contract is to procure upgraded network connectivity for Nottinghamshire Police in order to deploy the full solution. The solution will see some 40 Nottinghamshire sites connected via a single secure MPLS cloud giving flexibility for growth. This will provide a consistent core provision of hardware/connectivity to meet the requirements of the next 5 – 10 years.
