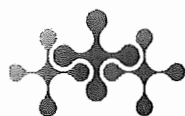

TITLE: CN1001852 NOTTINGHAMSHIRE POLICE AND CRIME SURVEY**EXECUTIVE SUMMARY:**

In 2017, the PCC commissioned Information By Design as part of a competitive tendering process to undertake a robust and representative general population survey for the police force area which set the baseline for monitoring Police and Crime Plan delivery outcomes and enhancing our understanding of:

- Prevalence, frequency and impact of crime experienced by local residents
- Levels of crime reported to the police and reasons for not reporting
- The needs of victims of crime and extent to which those needs are met
- Customer insight, including preferred reporting and engagement methods
- Public views on policing priorities and the precept for policing
- Perceptions of and levels of trust and confidence in local police
- Feelings of safety at home, within the local community and online

This report recommends approval, by signing; for entering into a contract extension with Information By Design for the provision of the Police and Crime Survey at an annual cost of **£32,000** over the period 1 August 2018 to 31 July 2021.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The contract was awarded to Information By Design in 2017 as part of a competitive tendering process. Given the quality of the fieldwork work undertaken during the baseline year, competitive pricing and benefits of maintaining continuity of service it is recommended that the contract is extended to cover the remaining Police and Crime Plan period. Further information on the procurement process and its outcomes can be made available from EMSCU if required.

The Police and Crime Survey has been designed to support and complement the following strategic divers:-

- The PCC Police and Crime Plan and performance framework for 2018-21
- The Nottinghamshire Police continuous improvement programme / priority plan
- The need to further develop our understanding of communities – as identified via the 2016 round of HMIC PEEL inspections.
- Statutory duties to engage with local communities on local policing matters, consult with local people in identifying and setting local priorities and consult the public and local rate payers prior to issuing the policing precept.
- Commissioner's and Chief Constable's shared ambition to "give victims and citizens a bigger voice in policing" and to "engage our communities to ensure we understand their needs".


