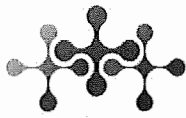

**TITLE: Additional Commissioned Project – Harmless CIC**

**EXECUTIVE SUMMARY:**

The PCC is requested to confirm his verbal agreement to use the PCC and Chief Constable's joint fund to support Harmless CIC in delivering The Tomorrow Project for the remainder of 2018-9.


**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

Harmless CIC originally applied to the 2018/19 Community Safety Fund and were unsuccessful. However following further development of a business case and discussions with Nottinghamshire Police Force, the PCC has agreed that this will be met from the joint initiatives fund.

Up to £24,759 will be provided to Harmless CIC to deliver The Tomorrow Project. This project will deliver an evidence based primary care suicide bereavement service across Nottinghamshire to people who would otherwise not be able to access help or service under current provision. This work has already been piloted across Nottinghamshire with the logistics and successful outcomes being demonstrated.


