### **EXECUTIVE SUMMARY:**

Nottinghamshire Police have conducted an Open EU procurement process for a Command and Control System including an integrated Communications Control System (ICCS) for the supply of SAFE (Situational Awareness for Enhanced Security) command and control

The contract period will be over 10 years (7 years with the option to extend for a further three year period) and the preferred bidder is SAAB Limited.

## **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

The tender was run as "Most Economical Advantageous Tender" with the evaluation criteria being 70% based upon Quality Questions & 30% Cost.

Forty seven (47) companies registered their interest initially in the tender documents. During the clarification period this reduced to twenty one (21) companies showing interest in the clarification questions. Finally four (4) formal offer submissions were received.

### FINANCIAL INFORMATION

The initial financial budget for this procurement was £7,200,000.00 across the lifetime of the contract (10 years).

The proposed contract value over the 10 year time period is £5,801,277.81. This is split as follows:

Capital Costs £3,112,060.55 (over 10 years) Revenue Costs £2,689,217.26 (over 10 years)
