**TITLE: YOUTH COMMISSION 2018/19**

**EXECUTIVE SUMMARY:**

The PCC plans to commission Leaders Unlocked to deliver targeted engagement with young people and under-represented groups across Nottinghamshire in 2018/19. 20-25 young adults from diverse backgrounds will be recruited and trained to join the Youth Commission which will include harder-to-reach groups such as ex-offenders.

Having delivered a highly successful project during 2016/17 and 2017/18, the PCC is keen to maintain the continuity of engagement and support being provided to members. The PCC also recognises the value that of Leaders Unlocked national infrastructure which has led to sharing of ideas and good practice among other national Youth Commissions and the involvement of Nottinghamshire members in relevant national programmes of activity.
