TITLE: Community Safety Grant 2019-20

EXECUTIVE SUMMARY:

The PCC is requested to confirm his verbal agreement to use 2019-20 Community Safety Grant to:

Award up to £724,557 of the Community Safety Grant to the Nottingham Crime and Drugs Partnership (CDP), subject to a satisfactory delivery plan, to include the following areas of work:

- Criminal justice substance misuse services: up to £293,876
- Substance misuse service for young people: up to £28,284
- Contribution towards IOM Accommodation: up to £50,000
- Contribution towards IOM IDVA work: up to £60,000
- Contribution towards Redthread: up to £35,000
- IOM Knife crime Non Statutory work for over 18yrs: up to £35,000
- Contribution towards CDP staffing: up to £100,000
- Knife Crime/Violence Reduction Joint Commissioning Fund with OPCC: up to £122,397.

Award up to £625,118 of the Community Safety Grant to the Safer Nottinghamshire Board (SNB), subject to a satisfactory delivery plan, to include the following areas of work:

- Neighbourhood working: up to £270,750
- Contribution towards IOM IDVA work: up to £20,000
- Project Officer to assist Neighbourhood Problem Solving and severity work: up to £60,000
- IOM Knife crime Non Statutory work for over 18yrs: up to £35,000
- Youth Crime Reduction: up to £109,000
- SNB/OPCC Joint Commissioning Budget: up to £130,368.

Award up to £254,174 of the Community Safety Grant in small grants to 20 third sector organisations through the 2019-20 Community Safety Fund to fund the following objectives:

- Programmes to raise awareness and help keep young people safe online, focusing on preventing child exploitation, bullying, sexting and technologically-assisted harmful sexual behaviour.
- Prevention and awareness raising initiatives to help keep vulnerable people safe from the emerging threats of cyber fraud and/or face to face doorstep fraud and rogue traders.
- Community led initiatives to help identify, tackle and reduce hidden harm. This may include projects to address the underreporting of FGM or CSE (particularly CSE amongst boys and

minority communities), human trafficking and other crime impacting upon those least likely to report to the police.

- Targeted education and awareness raising initiatives with young people, parents and the wider community with regard to substance misuse, including New Psychoactive Substances.
- Community led initiatives to increase reporting of local issues and improve victim trust and confidence in the police.
- Prevention and awareness raising initiatives to help keep rural businesses safe from the ongoing threats of specific rural business crime.
- Specific targeted and focused programmes or activity to divert children and young people away from crime and anti-social behaviour.
- Community level problem solving approaches to address the new and emerging localised risks and problems faced by local people everyday.
- Community led initiatives to reduce serious acquisitive crimes, such as vehicle crime and domestic burglary, including traditional evidence-led target hardening activity.
- Community led initiatives that promote community cohesion, strengthen sense of belonging within communities and empower local people to help achieve their ambitions.
- Community led initiatives to prevent hate crime and raise public awareness.
- Community led initiatives working in partnership with Nottinghamshire Police to facilitate
 positive relationships between BME and/or new and emerging communities and
 Nottinghamshire Police.
- Community led initiatives to improve the trust and confidence in the police amongst the more rural communities.

Award up to £15,000 of the Community Safety Grant to Nottinghamshire Community Foundation as a donation to the match funding for the Youth Social Action Fund/#iwill Programme. The aim of the Youth Social Action Fund is to increase youth volunteering and social action. Local groups can apply to Nottinghamshire Community Foundation for small grants for youth social action projects.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In previous years the PCC has awarded community safety grants to the Nottingham Crime and Drugs Partnership and the Safer Nottinghamshire Board to lead and deliver initiatives to achieve the strategic goals in the Nottinghamshire Police & Crime Plan. He has also supported the third sector to deliver initiatives through his Community Safety Fund.

Grant to the CDP and SNB (nos 1 and 2 above)

The CDP and SNB are key partners for the PCC. The grant will fund work to deliver the goals in the Nottinghamshire Police and Crime Plan.

Community Safety Fund (no 3 above)

The small grant recipients were selected through a robust assessment process in which all applications were assessed by two officers from NOPCC against a scored matrix. A draft funding list was submitted to an independent funding panel which included senior police officers, representatives from the CDP and SNB as well as expert input from specialists (eg hate crime, CSE) where required. The panel agreed the final list of recommendations which went to the PCC. The PCC agreed that 20 projects would be funded to a total value of £254,174. The projects are

Youth Social Action Fund/#iwill Programme (no 4 above)

Youth social action has huge potential to create enjoyable opportunities and skills development for young people, benefiting local people and places. The aim of this grant programme is to raise the level and quality of youth social action. Social action involves activities such as campaigning, fundraising and volunteering, all of which enable participants to make a positive difference to their communities.
