TITLE: Joint FHQ New Build

### **EXECUTIVE SUMMARY:**

The 2019-24 Capital Programme which was presented at the Police and Crime Panel meeting on 7<sup>th</sup> February 2019 and subsequently approved by the Police Crime Commissioner on a decision record. This approved a budget for the Joint FHQ New Build to the value of £0.352m in 2019-20 and future years budget of £14.474.

The original budget was assumed net of Fire contribution, with a revised budget being recommended at FEB in February 2019 of £18.5m. The budget will be re-phased to this level in the 2020-25 Capital Programme.

Due to the lower original budget being set and the momentum of speed that the project is gathering it is requested that £900k of the budget allocated for future years is brought forward to 2019-20 to off-set ground works and other preliminary charges.
