TITLE: Diva Concert

EXECUTIVE SUMMARY:

To seek agreement for £1,000 funding to support a concert in celebration of International Women's Day on Sunday 8th March 2020, with a share of the proceeds going to Nottingham Women's Centre.

The majority of the funding is to enable access for people who would not otherwise be able to afford to attend.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The Limelight Orchestra's celebration of International Women's Day is due to take place on Sunday 8th March 2020 at the Royal Concert Hall. Proceeds from the concert are to be shared with Nottingham Women's Centre. Over 50 musicians will perform ballads and dance music reflecting the contributions made by iconic female singers from the 1960s to the present day.

This links in with the Commissioner's Police and Crime Plan priorities around women's safety and tackling hate crime (including misogyny).

The funding would provide for 45 tickets for people who may otherwise not be able to afford a ticket: 25 to be allocated to service users by Nottingham Women's Centre at the charity's discretion and 20 tickets for quests of members of the Women's Centre Choir.

Of the £1,000 sponsorship of the event (which includes 10 tickets to be allocated by the OPCC), £877 is allocated to enable access for people who would otherwise not be able to afford a ticket.
