Award of contract for the construction phase of the New Nottinghamshire Police Custody Suite (Riba Stage 5-7) to Willmott Dixon Construction Limited (WDCL) following an EU compliant process via the SCAPE Procure Framework

#### INFORMATION IN SUPPORT OF DECISION:

The tender process has been through the EU compliant SCAPE Procure framework to ensure that Nottinghamshire Police & the Office of the Police & Crime Commissioner comply with The Public Contracts Regulations 2015.

WDCL are the sole supplier under the framework for the Major Works England and Northern Ireland lot which the value of this contract falls under.

To ensure value for money, Gleeds - experts in property and construction projects, have been engaged under a separate contract to act as building and cost consultants. They have carried out a thorough review, analysis and comparison of the cost elements submitted by WDCL.

The contract for the construction phase of New Custody Suite is to be awarded to Willmott Dixon Construction Limited (WDCL) for a total contract value of £15,300,000 on a fixed price basis subject to the occurrence of any of the contractually identified Employers Risks or Employers changes to the specification. The identified Employers Risks amount to £239,000. Thus keeping within the overall budget for the project of £15,600,000.
