TITLE: Amendments to the Nottinghamshire Victim CARE Website**EXECUTIVE SUMMARY:**

Up to £800 funding is being sought to enable changes to be made to the Nottinghamshire Victim CARE website to ensure that it is compliant with new accessibility guidelines and is as accessible as possible to all those who need help in Nottingham/Nottinghamshire.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The PCC currently commissions the Nottinghamshire Victims' CARE (Cope And Recovery Empowerment) service. The service provides victim-centred and outcomes focussed restorative and other support to empower victims and survivors to cope and recover from crime, anti-social behaviour, hate incidents and identity theft. It empowers resilience, protecting victims from further harm and helping to prevent repeat victimisation.

In 2018 the PCC commissioned a new Nottinghamshire Victims' CARE website to support and promote the help available for victims and survivors of crime in Nottingham and Nottinghamshire (please see previous decision forms 2018.065, 2018.092 and 2019.001 for further background information).

Since the website was developed new guidelines around website accessibility have been produced and following an audit of the Victim CARE website there is one area where the website does not meet the new guidelines. These changes can only be undertaken by the website design company (PDMS) and once they have made the changes they will audit it again to ensure it is fully compliant with the new guidelines.

The £800 is revenue funding and will be met from the 2020/21 other commissioning budget.
