EXECUTIVE SUMMARY:

Up to £13,500 funding contribution is being sought to support the 2020 Black Achievers Awards event in Nottingham.

The Black Achievers Awards aims to bring together people from all walks of Nottingham to recognise and promote the achievements of our BME community. PCC and Police involvement in this event aligns to the commitment in the Police and Crime Plan to "invest in community led initiatives to facilitate positive relationships between the BME community and the police".

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The aim of the Black Achievers Awards is to recognise and promote the achievements of the BME community in Nottingham and Nottinghamshire.
