**TITLE:** CED Funding 2019/20 and 2020/21

**EXECUTIVE SUMMARY:**

In line with the Home Secretary's 27<sup>th</sup> September 2020 announcement, the Home Office is making up to an additional £10million of grant funding available to increase the number of police officers carrying Conducted Energy Devices (CEDs) to help protect them and the public from harm.

The Grant awarded to Nottinghamshire Police is £28,875 for 2019/20 and £86,625 for 2020/21. This grant will be treated as capital which is a change to the approved capital programmes for those years.
