TITLE: Bonus & Excess Protection Insurance

EXECUTIVE SUMMARY:

This is a self - financing policy offered to employees to protect their no claims and reimburse excess values for damage to vehicles whilst parked in police owned car parks. The policy is paid for at the start of each financial year and then monthly deductions from payroll are made from employees signed up to the scheme.

Our only involvement in the scheme, besides making the payroll deductions is to provide the employee with a claim form for them to then deal with the insurance company directly.

The charge per month (£1.81) has been in place for a number of years.

In past years there has been an income surplus on this scheme which has meant that an increase to employees has not been necessary.

With the renewal charge this year (£8518.24) being 27% higher than in 2019-20 (£6,726.24), and a drop in employee numbers by approximately 25 each year (currently 348), there is a pressing need to increase the monthly charge, to ensure that the policy cost is not being subsidised by public funds.

An increase of £0.23 per month would cover the cost exactly, not allowing for anyone leaving the scheme, usually through retirement and resignation.

I recommend an increase of £0.69, to £2.50 per month is communicated by the Force to all staff, allowing those which wish to withdraw from the scheme can do so, implementing the new price from July 1st 2020.
