TITLE: Women-Specific Conditional Caution Project – Grant Extension

EXECUTIVE SUMMARY:

The PCC is requested to confirm his verbal commitment to a six month extension to the Women Specific Cautions Project delivered by Changing Lives to run from April to September 2020. This extension will enable changes to the force's Out of Court Disposal framework the opportunity to embed before this work and the wider women's work agenda is considered for commissioning. .

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The Women Specific Cautions (WSCs) project aim to prevent reoffending/escalation among low-medium risk women offenders via a time limited period of support and early intervention. The pathway forms an integral part of the force's revised out of court disposal framework which is currently being implemented. Outcomes over the coming months will be used to inform the development of a multi-year open tender.


