#### **EXECUTIVE SUMMARY:**

The PCC intends to issue a further grant to Leaders Unlocked to deliver targeted engagement with young people and under-represented groups across Nottinghamshire during 2020/21. 20-25 young people aged 14 to 25 will be recruited and trained to join the Youth Commission. The Commission will engage young people from diverse backgrounds, including harder-to-reach groups with experience of the criminal justice system.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The PCC intended to initiate a competitive tendering process for the Youth Commission in 2020 in order to secure a multi-year service that would run concurrently with the new PCC term of office. As a result of measures to control the COVID-19 pandemic, PCC elections have been deferred to May 2021. New commissioning arrangements for the Nottinghamshire Youth Commission will therefore also be deferred to 2021.
