TITLE: Children's Independent Sexual Violence Adviser (CHISVA) Service Uplift and Contract Extension

## **EXECUTIVE SUMMARY:**

As outlined in Notice of Decision 2018.050, the PCC agreed to award a contract to deliver a CHISVA service until 30 June 2020 to Imara. In October 2019 the PCC agreed a financial uplift to the service of £9,250 to run from September 2019 to June 2020 (Notice of Decision 2019.059).

In 2019 the PCC successfully applied to Ministry of Justice (MoJ) for additional CHISVA funding. The funding was confirmed in March 2020, with MoJ stipulating that the funding should pay for 1.5 extra CHISVA staff for the 2020/1 and 20212 financial years.

Imara's CHISVA contract will expire on 30 June 2020. The original Invitation to Tender made allowance for two possible one year extensions.

The PCC is requested to approve:

- 1. An increase in Imara's contract value for April June 2020 of £16,718.75. This will be paid for by the additional MoJ CHISVA grant
- 2. A contract extension to Imara to provide a CHISVA service for the period July 2020 to June 2021, at a total cost of £185,504.80. This will be paid for by MoJ grant, which includes the additional MoJ CHISVA funding awarded.

## INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The PCC made a strong funding application to MoJ, which clearly the demonstrated need for additional CHISVA funding. He was one of 15 PCCs which secured additional funding.

The CHISVA service provides vital support to children and young people who have experienced sexual violence and abuse. The PCC has received very positive feedback from survivors about the service and wishes it to continue.

Procurement advice was sought and is as follows:

- 1. The contract extension is permitted under the terms of the original ITT.
- 2. The additional MoJ CHISVA funding has been added to Imara's contract for the following reasons:
- The funding was awarded by MoJ in March 2020, with the expectation that support would begin in April 2020, allowing no time for a further ITT;

- Covid 19 arrangements in late March and April created further difficulties in publishing a tender for additional CHISVA provision; and
- Publishing a new ITT for the additional MoJ CHISVA funding might have resulted in a different CHISVA provider, which would have fragmented provision for children and young people, causing confusion for survivors. Survivors have told the PCC many times that they prefer to have a single service to go to for support.
