TITLE: Night time levy (No Place for Hate Initiative)

EXECUTIVE SUMMARY:

To seek approval for spending of £3,000 from the Late Night Levy monies to enable continuation of the No Place for Hate City Centre Charter. In particular, to support the hate crime training to Night Time Economy (NTE) venues and City centre businesses, an essential element of the Charter.

Hate Crime is a priority in the Police and Crime Plan, with a commitment to reduce repeat victimisation. Analysis shows that the majority of repeat victims of hate crime in the City Centre are NTE workers. The project has been designed specifically to support and empower victims to report.

The proposed expenditure is also consistent with the core aims of the Late Night Levy monies, in promoting a safer NTE for Nottingham.
