TITLE: Joint Police and Partnership Problem Solving Training - Travel and Subsistence costs

# **EXECUTIVE SUMMARY:**

In October 2019, a decision was approved to provide £19,925 funding toward Partnership Problem Solving Training but due to the outbreak of Covid-19 and Government social distancing regulations, a number of planned training sessions had to be cancelled in March 2020.

A new decision is sought to approve £3,350 to fund the remaining Problem Solving training for Police Officers, Police Staff and Partners in support of a recommendation arising out of the Neighbourhood Policing review to reinvigorate effective partnership working and support activity to reduce high severity crime in high harm localities was approved on 24th October 2019 (see decision 2019.056).
