**TITLE:** New Adult Sexual Assault Referral Centre (SARC)**EXECUTIVE SUMMARY:**

The Office of Police Crime Commissioner (OPCC), National Health Service England (NHSE) and Nottinghamshire Police have worked together to review the current provision of Sexual Assault Referral Centre (SARC) services in Nottinghamshire and to identify the changes required to provide a better standard of victim care and an improved standard of forensic evidence as required in forthcoming accreditation standards.

The Chief Constable and the Commissioner have accelerated the development of this project. Effective budgeting has created an affordable fiscal envelope and the views of a selective group of victims have helped to inform the preferred operational option. The paper recommends a brand new, fit for purpose SARC [REDACTED]

The contract for the new build is to be awarded to Perfect Circle JV limited via the SCAPE BECS Framework, thus ensuring a compliant route to market. Work on site is scheduled to commence immediately on confirmation of award and completion is scheduled for 28<sup>th</sup> February 2022.

As noted above the award is via the SCAPE BECS framework and is thus compliant with OJEU procurement process to ensure that Nottinghamshire Police, together with the Office of the Police & Crime Commissioner complied with The Public Contracts Regulations 2015.
