TITLE: Property Act Fund

EXECUTIVE SUMMARY:

Two project teams have been set up and created to assess, review and remove property held by Nottinghamshire Police that is no longer required.

The projects so far have solely been funded by Nottinghamshire Police, and work is still ongoing to complete.

Reg 6 of the Police Property Regulations 1997 states:

- The moneys, including income from investments standing to the credit of the Fund shall be applicable-
- (a) to defray expenses incurred in the conveyance, storage and safe custody of the property and in connection with its sale and otherwise in executing these Regulations;

Advice received from Legal Services is that the money available in the PPAF can be used to support this decision record.

It is requested that funding of £146,616 is made available to support the work being undertaken.

The force currently employees 6 staff on temporary contracts for the sole purpose of assessing, reviewing and removing property no longer requested.

Total overall for both projects, predicted 20/21 staff pay outturn is £146,616.
