**TITLE: Additional Funded Work 2020/21**

#### **EXECUTIVE SUMMARY:**

The PCC is asked to confirm his verbal agreement to award funding to support the following initiatives:

1. Rhodesia Target Hardening Project – Up to £3,000
2. Ongoing consultancy support from Star Fish Consulting to continue to enable the national adoption of the Nottinghamshire misogyny model – Up to £7,250

This is a total of up to £10,250 which shall be met from within the 2020/21 Commissioning budget.

#### **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

A proposal/application form for each of the above initiatives has been considered by the Commissioner as follows:

1. Up to £3,000 match funding to enable Rhodesia Parish Council and Rhodesia Post Office to purchase and install target hardening measures outside Rhodesia Post Office to ensure the premises are secure and protected from any potential ram raids. Funding has already been secured from the Parish Council, Councillors and the shopkeeper. The shopkeeper has agreed that he will be responsible for any ongoing maintenance. Funding will be provided to Rhodesia Parish Council and they will manage the project going forwards.
2. In 2018 a contract was provided to Star Fish Consulting to enable the national adoption of the Nottinghamshire model. The contract ran from 1<sup>st</sup> November 2018 to 30<sup>th</sup> June 2020 and allowed for 18 days consultancy work plus expenses (see previous decision record 2019.004). In 2018 the contract was awarded directly to Star Fish consulting as they had the necessary connections within the field but locally and nationally and prior knowledge of the Nottinghamshire Misogyny Scheme to enable them to be best equipped to carry out this work.

Ongoing work in this area is still required and in order to ensure continuity funding is requested to provide Star Fish Consulting with a new contract running from 1<sup>st</sup> July 2020 to 31<sup>st</sup> May 2021 which allows for 11 days consultancy work plus expenses in addition to 1.5 days carried over from the previous contract which were unable to be completed due to Covid 19.

As with the previous contract The consultancy days will only be used to support the following activities and deliverables:

- Supporting and enabling the National Police Chief's Council (NPCC) to adopt the Nottinghamshire's Misogyny scheme.
- Briefing and gaining support from individual forces to adopt the Nottinghamshire Misogyny

scheme locally and at a national level.

- Sharing best practice by speaking at conferences and undertaking media work.
