TITLE: Nimble Storage Refresh

EXECUTIVE SUMMARY:

Nottinghamshire Police IS Department have identified the need to replace/refresh three HP Nimble Storage Arrays. These three arrays have been identified as reaching the end of their vendor support life which will represent a risk. The identified arrays house the Force wide virtualisation services with an amount of data replicated between two units. The third is known as DFU and largely holds file share data. The current storage utilisation and performance has been reviewed utilising information collated by HPE InfoSight. This allows an accurate picture of how the array is performing and what the upgrade path could look like based on the real workloads running against the individual arrays.

Due to age and condition the software for this array will no longer be updated or perhaps more importantly, patched. Once a device has passed the point of end of support, patches will not be generated for new issues uncovered leaving scope for security issues to go unresolved. This creates significant operational risk for the force Due to the need to engage with external information system experts and obtain value for money the EMSCU ICTVAR framework has been utilised thus ensuring a compliant route to market via CDW.

Three solutions form leading providers, HPE, Dell and Netapp, were evaluated to ensure pricing was met. All three solutions are technically compatible.

For operational reasons and to ensure budget certainty a five year HPE package has been selected from CDW at a cost of £282,378.34
