### TITLE:

Refurbishment of Mansfield Road Police Station

### EXECUTIVE SUMMARY:

At Mansfield Police Station there is currently a space known as Northern Control Room that the Force have decided should become a dual purpose space and used as a Control Room and three IT training rooms. The work will involve a remodelling of the main room to divide it up into three rooms that can then be opened up into a Control Room when required.

Perfect Circle were contracted to produce designs in March '19 (SOR1000977 / CN100283) Business requirement subsequently changed and following discussion with affected teams the timescale for completion of the project revised.

The contract for the works is to be awarded to Lindum Group Limited for a total contract value of £309,316.58 on a fixed price basis subject to the occurrence of any contractually agreed Compensation Events.

The process has been through the SCAPE Regional Construction framework Agreement and is thus compliant with EU procurement regulations.


