**TITLE: Women-Specific Conditional Caution Project – Grant Extension**

#### **EXECUTIVE SUMMARY:**

The PCC is requested to confirm his verbal commitment to a 12 month extension to the Women Specific Cautions Project delivered by Changing Lives to run from 1 October 2020 to 30 September 2021. This extension will enable the pilot to assess service demand alongside changes to the force's Out of Court Disposal framework and inform future commissioning options following PCC elections in May 2021.

#### **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

The Women Specific Cautions (WSCs) project aims to prevent reoffending/escalation among low-medium risk women offenders via a time limited period of support and early intervention. The pathway forms an integral part of the force's revised out of court disposal framework which is currently being implemented. Outcomes over the coming months will be used to inform the development of a multi-year open tender.


