TITLE: Home Office Covid 19 Small Grants

EXECUTIVE SUMMARY:

This decision form seeks approval for recipients of the Covid 19 Small Grants funding provided by the Home Office. The Grant is intended to fund Projects that will positively impact on children and young people in both England and Wales. VRUs have been asked to distribute funding to smaller frontline charity partners to strengthen existing HO delivery infrastructure and new charities that provide vital services.

Money has been allocated to VRUs based on their share of hospital admissions for knife injury, which is a proxy for local level of serious violence and is the existing allocation method for HO funding.

Nottingamshire has been awarded £74,720 which has been split between 20 microcharities, with each receiving £3736. Spend can be claimed from 1st April to 31st December 2020, all funds must be distributed by 31st October 2020.
