TITLE: Award of contract to provide a new sexual violence support hub and specialist therapy 2020-5

EXECUTIVE SUMMARY:

As outlined in Notice of Decision reference 2020.039, the PCC has agreed to act as the lead commissioner for a new sexual violence hub and therapy support contract. The service will be funded by Nottingham City Council, Nottinghamshire County Council, Bassetlaw CCG and Nottingham and Nottinghamshire CCGs as well as the PCC.

East Midlands Strategic Commercial Unit (EMSCU, now Mint) conducted an OJEU compliant procurement process. Following an evaluation of bids Notts SVS Services is the preferred bidder.

The contract will run from the period 1 October 2020 to 31 December 2023, with mobilisation taking place 1 October – 31 December and delivery from 1 January 2021. The total value of the contract to 31 December 2023 is £2,914,207.17, broken down as follows:

2020/1: £251,412.86 2021/2: £1,006,258.33 2022/3: £946,679.42 2023/4: £709.856.56

There is potential to extend the contract for two years 1+1 from 1 January 2024 to 31 December 2025. The contract also includes the option to include the PCC commissioned ISVA service into the contract from July 2022 to December and also allows for additional funding up to be added into the contract to fund counselling, should any additional national funding for counselling become available.

The PCC is requested to approve the following:

- 1. The award of the contract to deliver the sexual violence hub and therapy to Notts SVS Services, at a value of up to £2,914,207.17, with contract extensions and ISVA and counselling additions subject to further confirmation by the PCC and other funders;
- 2. To provide a total of up to £992,501 PCC funding as for the service as follows:

2020/1: £83,958 2021/2: £355,834 2022/3: £315,833 2022/4: £236,876

The procurement process was managed by EMSCU (now Mint) and was fully OJEU compliant. Two bids were received. Independent panels were held to score the bids, which consisted of a representative from each funding agency, as well as 3 survivors. Bids had to meet quality and financial threshold scores.

NSVSS was the highest scoring bidder. The tender award form is attached.
