TITLE: Review of Neighbourhood Offices

EXECUTIVE SUMMARY:

Following a review of Neighbourhood Offices, it was agreed that consultation would take place on the potential closure of five Neighbourhood Offices at the following locations:-

- a. Bingham Town Council Offices
- b. Carlton in Lindrick Civic Centre
- c. Trowell Services Former Motorway Post
- d. Tuxford Mine of Information
- e. Warsop Town Hall

It should be noted that since the original decision to undertake the consultation took place, there has been an uplift in Police Officer numbers which puts greater pressure on existing facilities and where dedicated Beat Officers are now available in new areas, there is a greater likelihood that the Neighbourhood Offices will have greater usage and be a useful local facility at a low cost.

The outcome of the consultation is included in the attached Force Executive Board Report and following consideration by the Board, it is now proposed to recommend retention of the premises at Bingham, Carlton in Lindrick and Warsop, which form good, low cost accommodation for the local Beat Team.

The Police Office at Trowell Services is not a Neighbourhood Office but a location that was previously used by the Roads Policing team and is no longer required for operational purposes. The lease of these premises has now expired.

Agreement has recently been reached with Nottinghamshire Fire and Rescue Service to allow use of all Fire Stations for welfare purposes and there is a retained Fire Station in Tuxford which can be used as an alternative to the Mine of Information building, allowing savings to be made.
