# **TITLE: Additional MoJ Covid 19 Emergency Funding**

#### **EXECUTIVE SUMMARY:**

Further to Decision Notice 2020.046, the Ministry of Justice (MoJ) has granted Nottinghamshire Police and Crime Commissioner a further £369,960.28 Covid 19 Emergency Funding. This funding is for charities and social enterprises that support victims of domestic or sexual abuse to cope with the impacts of crime, and, as far as possible, recover from the harm they have experienced. The funding is provided to meet additional costs occurred as a result of adapting services due to COVID-19 or to meet additional demand as a result of COVID-19.

Following receipt of detailed needs assessments from organisations the PCC is requested to confirm his verbal agreement to use this funding as follows – and as per the Grant Variation received from the MoJ:

# INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In May 2020 the Nottinghamshire Police and Crime Commissioner was allocated funding from the MOJ for charities supporting individuals experiencing domestic or sexual abuse. The funding was for registered charities and social enterprises to meet additional costs occurred as a result of adapting services due to COVID-19 or to meet additional demand as a result of COVID-19. To be eligible, organisations must provide

support services which have the purpose of helping victims of domestic or sexual abuse to cope with the impacts of crime, and, as far as possible, recover from the harm they have experienced.

In November 2020 the Nottinghamshire Police and Crime Commissioner was allocated further funding from the MOJ totalling £369,960.28, This was again for organisations which support victims of domestic and sexual violence and was to meet additional costs occurred as a result of adapting services due to COVID-19 or to meet additional demand as a result of COVID-19.

Eligible organisations were asked to submit a needs assessment to the PCC. These needs assessments were collated and sent to the MOJ who subsequently confirmed Nottinghamshire's funding allocation of £369.960.28 to be distributed as follows:
