### **EXECUTIVE SUMMARY:**

The PCC is asked to confirm his verbal agreement to award funding for the following:

- 1. Real Talk TV Up to £2,500 via the Chayah Project
- 2. The commissioning of four virtual focus groups across the force area to gather residents' views on the policing budget and resources, the precept for policing and attitudes towards police officer safety Up to £5,900 to SMSR Research

This is a total of up to £8,400 which shall be met from within the 2020/21 Commissioning budget.

# INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A proposal/application form for each of the above initiatives has been considered by the Commissioner as follows:

- 1. Real Talk TV is a new initiative which aims to give back people and the wider under represented community the opportunity to have their own platform to discuss real life, lived experiences and develop positive solutions to make an impact on change. Real Talk TV is working closely with the Chayah Project who will act as the accountable body for Real Talk TV. All the project activity is currently being undertaken online. PCC funding of up to £2,500 has been made available to cover the costs of equipment hire between 1<sup>st</sup> November 2020 and 31<sup>st</sup> March 2021.
- 2. Focus groups are required to obtain an informed view on attitudes towards the police budget and precept in accordance with his statutory duties. They provide an opportunity to explore resident attitudes in greater detail. A specification has been drawn up and a quote provided by SMSR Research to provide a series of four virtual focus groups between December 2020 and January 2021. This work will build upon research undertaken in previous years and supplement the Commissioner's Police and Crime survey which is administered on a rolling basis throughout the year. The four focus groups will explore:
  - Local priorities for policing in the context of recent and planned policing activity
  - The impact of the Coronavirus pandemic on crime and anti-social behaviour in the community, community cohesion and feelings of safety
  - Attitudes towards the local precept for policing and levels of support (or otherwise) for an increase in the precept for policing.
