EXECUTIVE SUMMARY:

To inform and recommend approval for the variation of contract for AV equipment within the Joint Force Headquarters building to Henry Brothers Construction Limited, for the supply of AV Equipment to be fitted as part of new the Joint Force HQ building for the period of contract for the total compensation event value of £389,579.40 ex VAT.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

As part of the full OJEU procurement for the construction of the Nottinghamshire Police & Nottinghamshire Fire & Rescue JFHQ building advertised at £18.5m all 6 contractors to price for the AV (Audio Visual Equipment) for the building. An amount of £630,000 was set aside for these works (as part of the overall approved budget) This estimation was produced by AJAR the organisation who produced the original AV specification on behalf of the Force.

Therefore, a three-bidder process was conducted to define the best the value. Firstly, all three companies provided quotes and were then invited to a supplier's event in September 2020, that was attended by Nottinghamshire Police / Nottinghamshire Fire & Rescue the JFHQ Design Team and Gleeds (the Project Consultants)

Gleeds have reviewed the following additional costs included by Henry Brothers and are of the opinion they are fair and reasonable and in line with the original tender allowances.

Gleeds can confirm the amount of £348,544.00 is as per the GV multimedia quotation which has been reviewed by Nottinghamshire Police.

The recommendation is to award the contract to GV Audio via Henry Brothers through a compensation event (Construction Contract Change Control) at a cost of £348,544.00. The total value of the award is £389,579.40 which includes the Principal Contractor costs overheads and profit.
