EXECUTIVE SUMMARY:

Commissioner Henry has planned a series of "Have Your Say" engagement events to listen and learn from residents over the summer and early autumn of 2021. These events will shape her new Police and Crime Plan for Nottinghamshire. Eight community based events will be held between 12 August and 12 October 2021, in addition to a number of thematic events.

The community based events will be both in person (Covid restrictions permitting) and streamed live. The Commissioner seeks a provider of videography support for the eight place based community events, plus additional videography support on a call off basis.

The Commissioner is requested to approve:

- the publication of a request for proposals for video based support for 8 community events and a daily call off rate for further videography support for up to 9 events, at a total cost of no more than £30.000
- the invitation of a selected list of suppliers to bid for the work.

This will be funded out of the Commissioner's OPCC budget.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The Commissioner has a statutory duty to set police and crime objectives for Nottinghamshire in a new Police and Crime Plan. In addition, as Police and Crime Commissioners bring the voice of the people into policing, she must also consult with local people to determine the Police and Crime Plan objectives.

The Police and Crime Panel has requested that the new Police and Crime Plan is presented to them by November 2021, with draft priorities going to the September Police and Crime Panel. In order to meet this timescale, the Commissioner has planned a comprehensive engagement schedule of Have Your Say community events from mid-August. Whilst the events will be held in person wherever possible, there is a need to ensure that the events can be easily accessed by all Nottinghamshire residents regardless of any potential Covid related restrictions.

The Commissioner would like to live stream the events via Facebook, with participants having the ability to ask questions and make comments. There is currently no facility to provide the live streaming support

in house within the OPCC or via any of the contracts the Commissioner currently has in place. The videography support must be externally procured and is urgently required as the first event is in mid-August. The Commissioner's Contract Standing Orders allow for direct awards to be made in specific circumstances. In this instance the Commissioner would like to run a very quick procurement exercise asking 4 providers to quote, in order to allow for some competition within a very limited timescale. The procurement will be completed within a week. It is therefore recommended that the Commissioner publish the opportunity on the Commissioner's website and to invite a select list of suppliers to quote. The suppliers that will be invited to quote are: **Better Times** Millbank MGL My Town Vision Bids will be assessed for quality and price.
