**TITLE: Home Office Covid 19 Small Grants**

#### **EXECUTIVE SUMMARY:**

This decision form seeks approval for recipients of the Winter Contingency fund provided by the Home Office. The Home Office has provided a Grant of £52,080 to the Nottingham and Nottinghamshire VRU to distribute to charitable organisations and social enterprises with the means to rapidly boost their support offer, helping to ensure that children and young people are kept safe from serious violence, county-lines activity and other forms of exploitation. The funding will be used to mitigate negative effects to protective factors caused by COVID-19 related restrictive measures.

Charities/social enterprises have until 31<sup>st</sup> March to spend their funding and they will be able to claim for any cost incurred since 5<sup>th</sup> November (this date represents the start of the recent national Covid-19 restrictions).

#### **Eligible expenditure:**

The following costs/payments will be classified as Eligible Expenditure:

- Salary costs, in whole or as a portion, comprising basic salary, employer pension contribution, recruitment & retention allowances and statutory sick pay
- any cost incurred by a Project Implementation Partner that enables delivery of the purpose. This includes use of technology, for example, laptops.
