**TITLE: NHS England Surge Funding – COVID 19 and Support for Voluntary Sector Sexual Violence Support Services**

**EXECUTIVE SUMMARY:**

The PCC is asked to confirm his agreement to provide Nottinghamshire SVSS with an additional £65,362 NHSE surge funding via their Sexual Violence Hub contract to provide services which will help to maintain safety and support in the community following the anticipated surge in victims and survivors coming forwards following the cessation of Covid restrictions and social distancing.

**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

NHS England has provided Nottinghamshire SVSS via the Police and Crime Commissioner for Nottinghamshire with non-recurrent funding of £65,362 to provide services which will help to maintain safety and support in the community following the anticipated surge in victims and survivors coming forwards following the cessation of Covid restrictions and social distancing.

The funding is to be used by Notts SVSS to provide support to survivors referred from the Sexual Assault Referral Centre (SARC). Eligible support includes:

- Funding for 6-10 sessions of short term, immediate support for SARC referrals
- Development of online/virtual platforms and resources to support SARC referrals
- Family/carer support for SARC clients
- Befriending service for SARC clients
- Other incentives to support SARC clients therapeutic needs as agreed with the OPCC.

This funding will be included in Notts SVSS Sexual Violence Hub contract and is permissible as the ITT allowed for national funding to be added if it became available. The funding will be for delivery in 2021/22.

Funding of £65,362 will be received by the PCC from NHS England and then paid out during 2021/22 to Notts SVSS in line with the revised contract.
