**TITLE: Violence Reduction Unit (VRU) – Proposed VRU budget from April 1<sup>st</sup> 2021 – March 31<sup>st</sup> 2022**

### EXECUTIVE SUMMARY:

This decision form outlines the VRU budget forecast from April 1<sup>st</sup> 2021 – March 31<sup>st</sup> 2022 and seeks approval of spend in line with conditions described in the VRU Home Office Grant Agreement.

This decision notice also seeks delegated authority for the VRU Director to take and implement decisions to spend funding in line with the proposed budget and OPCC financial regulations.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A bid for the dissemination of the £880,000 funding provisionally allocated to the Nottingham and Nottinghamshire VRU will be submitted to the Home Office in mid-April. This will be signed off by the Strategic Violence Reduction Board.

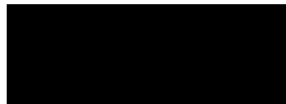
