TITLE: DSVA Helpline county contribution – contract award 2020-8

#### **EXECUTIVE SUMMARY:**

As outlined in Notice of Decision 2020.007, the PCC agreed domestic abuse funding could be used to support Nottinghamshire County Council's award of three separate contracts to deliver domestic abuse support services in the county to Juno Women's Aid, Nottinghamshire Women's and Equation.

The contracts were awarded under a framework, which included provision of the domestic abuse helpline.

The PCC is requested to confirm his earlier approval to provide £29,803.81pa to Nottinghamshire County Council to contribute towards delivery of the DSVA helpline for the period 2019-22, delivered by Juno Women's Aid as recommended by the County Council.

This will be funded by Community Safety Grant.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The DSVA helpline is funded by a number of funders including the City Council, County Council and the PCC. In addition, the provider contributes around £30k pa towards the cost of delivery, through voluntary sector fundraising and owns the phone number. No funder, either singly or working together, would be able to fund the service in entirety and it would not be practically feasible to tender part of the service. The County Council therefore recommended that it call off delivery of the contract under its existing framework agreement.
